Terms & Conditions

These comprise the total and the limit of the contractual agreement between you and the company. By accepting the use of a test you shall be deemed to accept the conditions herein:

1.Price and Payment

- 1.1 The price shall be the price quoted and shall be inclusive of delivery charges and any VAT due.
- 1.2 Payment shall be made either by cheque or credit card when placing your order.

2.Delivery

- 2.1 Delivery will be made by post within 14 days of receipt of order and cleared funds.
- 2.2 The company will not be liable for any delay in the delivery of the test kits.
- 2.3 If the company fails to deliver the test kit then you will be entitled to a full refund but the Company's liability will be limited to the amount accompanying your order.
- 2.4 Delivery will be to the address stipulated on the order form.

3.Damage or complaint

- 3.1 The test kit should be inspected upon receipt and any damage or shortfall reported to the company within 7 days of delivery. You will not be entitled to reject the test kit thereafter.

4.Order cancellation.

- 4.1 You are entitled under "cooling off" regulations to cancel your order. To do so you must within 7 days of delivery.
 - 4.1.1 Inform the company by email or by letter that you wish to cancel your order.
 - 4.1.2 Return the goods intact, undamaged and unused.
- 4.2 A refund will be made within 30 days of the order cancellation and return of the goods.

- 6.5 The test must be used in accordance with the instructions provided.

7.Limit of Responsibility

The Company does not accept responsibility for any condition or symptoms you develop caused by reaction to or consumption of any food or beverage.

8.Data & Information

You accept that in conducting the test the company will be processing data and communicating to you information about your test and the results.

9.Warranties & Limitations

The Company does not give any warranty in respect of the test or the results.
The Company's liability for any breach of contract shall be limited to the amount paid by you.
The Company does not accept liability for any loss, damage or injury except if caused by the Company's negligence.
